Criteria:

Who – The Scholarship is open to any burn survivor or family member of a burn survivor who is continuing their education beyond high school and is a current or former resident of Manitoba, Canada. There is no maximum number of applicants. The funds available for each year will be equally divided amongst the successful applicants. The maximum amount awarded to any one applicant will be \$500.

What – The fund will be used to assist with the financing of continued education beyond the high school level (any university, college, trade school or other post-secondary study).

Timing – Applications will be available on the Mamingwey Burn Survivor Society's website on or before April 1. The deadline for consideration in a given year is July 31. The applicants will be notified and the scholarships will be granted by September 1 of that year.

Applications:

Information that needs to be completed on the application: Name, address, phone number and email address; if the applicant is a burn survivor or relative of a burn survivor and who that burn survivor is; the name of institution where enrolled; proof of enrollment; brief explanation of why that course is of interest to you and outline of plans for the future.

If proof of enrollment cannot be provided at the time the scholarship application is submitted, then please ensure that your acceptance documents are submitted by the July 31 deadline in order for your application to be considered.

All applicants will be considered if the above criteria are met. Members of the Hart family and members of the Mamingwey Burn Survivor Society's planning committee are allowed to apply.

Awarding the Scholarship:

A panel of three members of the Mamingwey Burn Survivor Society will decide who the successful applicants are each year. One member on this panel will be a member of the Hart family.

All selected applicants will be asked to attend the annual Mamingwey Burn Survivor Society conference which takes place in October of each year. They will be asked to attend so they can be recognized by the Society as scholarship recipients. We also request that each successful applicant consent to having a photograph posted on the Mamingwey Burn Survivor Society website.

Funding:

As decided by the Mamingwey Burn Survivor Society, the funds for the Thomas W. Hart Memorial Scholarship will be renewed by proceeds of the Silent Auction that is held each year at the annual conference.
